ABOUT THE COMPETITION

In the virtual portfolio competition of Coinportal, the person with the most balance wins the competition by making profit and loss by buying and selling coins with 12.062 \$ (100,000 TL) given to the users who come to the virtual portfolio competition.

In order to trade in the competition, you must first create an account.

When creating an account, you must fill in the "Name and Surname", "Mail Address" and "Password" fields.

I also approve the "User Agreement" found under these fields. and "I consent to receive messages with Lighting Text." You must also tick the boxes. Otherwise, when you click the "Register" button, your registration will not take place.

After you become a member, a virtual balance of 12.062 \$ (100,000 TL) is defined for you to make transactions.

With this defined virtual balance, you can follow the current coin prices from the "Cryptocurrency Prices" menu and find the coin you want to trade in the "Cryptocurrency Buy and Sell" menu and perform transactions with that coin.

In the "My Assets" section, you can find information about the latest status of the coins you have.

ABOUT THE COMPETITION

From the "Contest Latest Status" section, you can reach both the top 3 rankings and your instant ranking status.

If you want to change your password by entering the "Security Settings" section in the menu on the left, you can perform your actions.

You can follow your movements by entering the "User Activity" section in the left-hand menu. If you see a transaction that does not belong to you, you should contact us.

You can see the people who registered with your reference link by entering the "My References" section in the menu on the left. If you see a transaction that does not belong to you, you should contact us.

You can view the history of all the transactions you have made so far by entering the "Transaction History" section in the menu on the left. If you see a transaction that does not belong to you, you should contact us.

At the end of the competition, winners must confirm their accounts in order to receive the prizes. Click on the menu icon on the upper left side of the account confirmation and enter my account information. From this section, fill in the TR Identity, Phone and Twitter tracking fields.

1. THE COMPETITION IS ORGANIZED BY THE COIN PORTAL, THE COIN PORTAL VIRTUAL PORTFOLIO COMPETITION PLATFORM (“bzetmex.coinportali.com”) WILL BE CARRIED OUT UNDER THE SPONSORSHIP OF BZETMEX TECHNOLOGY INC.
2. COIN PORTAL VIRTUAL PORTFOLIO COMPETITION PLATFORM OF ALL PARTICIPANTS AND BZETMEX.COM THEY MUST BE MEMBERS.
3. THE ORGANIZER OF THE COMPETITION IS THE COIN PORTAL. BZETMEX TECHNOLOGY INC. IS ONLY THE SPONSOR OF THIS COMPETITION, THERE IS NO INTERFERENCE IN THE RESULTS OF THE COMPETITION AND THE COMPETITION SYSTEM.

6. PARTICIPANTS CAN MAKE A PURCHASE AND SALE TRANSACTION WITH ANY CRYPTO CURRENCY BY ENTERING THE "BUY AND SELL CRYPTO MONEY" MENU WITH THE VIRTUAL BALANCE DEFINED FOR THEIR ACCOUNTS. INSTANT DATA WILL BE TAKEN INTO ACCOUNT WHEN PERFORMING THESE OPERATIONS.
7. THEY WILL BE INCLUDED IN THE RANKING ACCORDING TO THE AMOUNT OF PROFIT AND LOSS THEY WILL RECEIVE AT THE END OF THE COMPETITION.
